VENDOR ASSIGNMENT AND FACT SHEET

Note: You must keep this sheet for the entire duration of the race.

We truly appreciate your interest in being a part of the Great Texas Balloon Race. For many years, East Texans and visitors from around the country have attended the annual Great Texas Balloon Race. With weekend attendance exceeding 12,000 most years, it is undeniably the premier event in East Texas. Gate admission is charged. Gates will open at 4 p.m. Friday and Saturday, close at midnight. Vendors must stay open until 11 p.m. each night. Balloon glows are on Friday and Saturday evenings (weather permitting). In addition to the balloon activities, the event includes "Kids Land," musical entertainment each night, lots of fun arts and crafts and great food.

SET UP TIMES

Set up time will be: Thursday, June 11, 9:00 a.m. until 12 p.m. if Needed & Friday, June 12th 9:00 a.m until 12p p.m.

ALL booths must be set up by noon Friday. After 12:00 noon Friday, you must use the "vendor gate" only and no vehicles will be allowed inside fenced event space. Power will be provided.

- NOTE: Tables and chairs for your booths, set up and tear down activities, hoses, electrical cords, etc. are all the responsibility of the Vendor.**

No Silly String or Poppers are to be sold or given away.

No AC Units can be utilized in Booths.

Vehicles are allowed inside Longview Convention Complex only to load or unload; no driving inside after 12p Friday.

Vehicles must park in Vendor Parking or other designated parking.

No golf carts, scooters, mopeds, bicycles, three wheelers, four wheelers, go-carts or any similar vehicles will be permitted except for GTBR personnel.

No food or drinks permitted for sales but Commercial Vendors may provide complimentary water, promotional items, sample size edible snacks if packaged and for marketing purposes.

Vendors are required to dispose of all trash in the roll off container. Any violators will be charged a \$50.00 trash fee.

Two vehicle passes will be issued for use at the vendor gate. All other vehicles will be subject to parking in General Parking and purchasing a ticket at the gates.

- Ø PETS:** We understand that many vendors travel with their pets. You are to keep your pet(s) outside the Longview Convention Complex. Our concern is for the safety of your pets due to the extreme heat at the event.

The grounds will be secured and all gates will be locked at 1 a.m. and not reopened until 2:00 p.m. All vendors **must** have their booths secured and be off the property no later than 1:00 a.m.; a \$100 security fee penalty will be assessed for any exceptions. We do not allow camping in a vehicle on Longview Convention Complex grounds.
